प्रिय अभ्यर्थियों,

अवगत कराना है कि उक्त परीक्षा के अभ्यर्थियों द्वारा परीक्षा परिणाम के संबंध में आयोग से विभिन्न माध्यमों से जानकारी प्राप्त की जा रही है। सभी अभ्यर्थी भिज्ञ है कि इस परीक्षा के संबंध में माठ उच्च न्यायालय में विभिन्न वाद लंबित है तथापि आयोग द्वारा इस परीक्षा के परिणाम जारी करने के संबंध में कार्यवाही की गयी है।

इसके साथ ही इस मामलें में नियोक्ता विभाग(यू०पी०सी०एल०) के कुछ कार्मिकों द्वारा अपनी पदोन्नित के संबंध में एक रिट याचिका योजित की गयी है। इस याचिका में मा० उच्च न्यायालय द्वारा यह आदेश दिये गये हैं कि पदोन्नति तथा सीधी भर्ती का परिणाम साथ—साथ जारी किया जाय। मा० उच्च न्यायालय के आदेश की प्रति संलग्न है।

आयोग द्वारा नियोक्ता विभाग से इस संबंध में प्रभावी समन्वय किया जा रहा है व शीघ्र परिणाम जारी करने हेतू प्रयास किया जा रहा है।

Petitioner has filed interim relief application no.1 of 2021 alongwith prayer that the exercise for departmental promotion be taken prior to the selection process for direct recruitment.

The dispute is with regard to recruitment to the post of Junior Engineer in the Uttarakhand Power Corporation Limited. There are two modes of recruitments, one by way of promotion and another by way of direct recruitment. In promotion, there are two categories, one departmental promotion and another accelerated promotion, but, that is not an issue here.

The process for direct recruitment is halfway through as it is informed that pursuant to an advertisement issued in the year 2016, the written examination has already been conducted and anytime in future, the result may be declared and processed accordingly.

It is also the case that, in fact, the process for departmental promotion has also been initiated by respondent nos. 2 and 3 on 14.04.2020.

Learned counsel for respondent nos.2 and 3 states that records of the candidates

have already been received and the

department is processing them.

The Uttarakhand Power Corporation Limited Junior Engineer (Electrical and Mechanical) Service Regulation, 2018 are in force. Rule 18 of it-provides for determination of vacancies in a year so that they may be filled up. In fact, Rule 11 of it provides cut-off date for determining age.

Having considered the submissions, till the next date of listing, respondent nos.2 and 3 are restrained to give appointment either to direct recruit or to the promotional recruit,

independently.

Respondent nos. 2 and 3 are free to declare result of both the categories simultaneously.

Interim Relief Application No.1 of 2021

stands disposed of accordingly.
